
Then, we have our Second Annual Holiday Auction. We have had a wonderful response from local businesses. At press time some of the items we will be auctioning off include:

THE AUDUBON ORGANIZATION
National and Florida Audubon
Society are working to coordinate
services, planning and resource sin a new
'seamless' society which will work to
protect the environment and provide
habitat for birds and other wildlife. The
FAS Annual Meeting I attended recently
brought delegates up to date on these
efforts. Emphasis was placed on birds
and their habitat, using good science for
decision-making, and strengthening the
grassroots of the society - the local
chapters!

Local chapters continue to be autonomous. Yet these local chapters have many things in common. To build on these commonalities regional Audubon councils meet a few times a year. Recently, Cissie Durando and I traveled to Miami to attend the meeting of the Audubon Council of Southeast Florida.

This council is comprised of chapters in Palm Beach, Broward, Dade and Monroe counties. We have many similarities - large geographic regions, increasing populations, shrinking habitat and a growing need for water. Differences include - the size of membership, organizational structure and environmental priorities.

The Southeast Council decided to develop criteria to be used to judge the importance of regional conservation issues; strengthen our impact politically by reaching consensus and focusing on three high priority conservation issues; and establish goals to improve local chapter strength.

# Conservation Report . . . by Cissie Durando

As usual, another busy month, and is anyone really holding their breath for a report? Interesting political results have been analyze ad nauseum, so we'll leave that dog alone.

Our challenge to the South Florida Water Management District to issue a permit to develop part of the former "cell 6", or east coast buffer, adjacent to the Loxahatchee Refuge, was disallowed on a technicality by a hearing officer on a challenge in Tallahassee by the developer involved. We haven't rolled over yet; we are exploring other alternative.

There was a Florida Audubon Board Meeting November 2 & 3. A few things were sprung on the Board that were unexpected and with little time to "mull" over after presentation. I usually wish I could chat with our membership before I vote and get some other points of view. As much as I long for more thoughtful participation, it seems the NAS/FAS officers aim for more streamlined endorsements through the vote.

For instance: Officers
...commended taking Marine Fishery
Commission from the Department of
Environmental Protection and giving it
to the Game and Fresh Water Fish
Commission. The actual
accomplishments of the G&FWFC
have been so scarce and wimpy. I
would not give them another
assignment.

Also, how far down in the order or priorities would that shove their Non-Game Species Program if they had to

compete not only with the dry land "sportsman", but now the wet ones?

Another item that struck a chill in my heart: advocating one-stop "streamlined" permitting at the state level. Palm Beach County's best chance may be through local review and elegation of permitting authority to the county Environmental Resource Management Department.

Next: what do we want from our state legislators in the nest session for a Wetlands Mitigation Policy? There will be an open Legislative Delegation meeting at the School Board beginning at 9 a,.m. December 5th. There will also be meetings in North and South county on other dates. The public is not only welcome, but invited to speak your mind. Let's do it! The last controversial items at the Fla. Board meeting were a new non-status for Peter Pritchard, and a needed new financial plan hatched.

By far the most significant thing accomplished was putting together the 2-day workshop with the local Extension Department, exploring Sustainable Agriculture in South Florida. Especially as it related to Palm Beach County. I believe the last count totalled 157 signups with about 120 attended. Two long days of great presentations from crop people to pesticides & research; where are we? what can we expect? etc. Leah Schad valiantly attempted to keep things rolling on schedule. The presentations and questions they inspired caused her to fail. The audience was still there on

the second day as we ran 1 1/2 hours late! Does that spell S-U-C-C-E-S-S or what!

I represented our chapter at the opening ceremony on November 8 of the Wakodahatchee Wetlands. That should be high priority on any naturalist's list to visit. It is 50 acres of re-built wetlands and boardwalk with a wonderful assortment of bird and wetland plantings. Located on Jog Road between Atlantic Avenue and Boynton Beach Blvd, east side. A wonderful undertaking by the County Utilities Department with lots of moral support by locals.

Seems like our commissioners sit up late figuring how if they "giveth" how they can "taketh". I hope you all contacted a commissioner and reinforced the need for regulatory protection of native habitat if over 4 acres, regardless of the fact that the property is zoned residential. That meeting is November 26. If this newsletter comes in time, give a quick call and tell a secretary how you feel.

If this jumpy news report has yo befuddled do call if explanations are needed.

And - do we truly wish to see over \$300 million of state money and over \$6 billion in Federal bonding go towards a 1-1/2 hour trip to Orlando? The Hi-Speed Rail is marching right along! This could fund the Everglades Restoration without endless lawsuits, but is environmentally destructive in its own right.

# Issues To Act On . . . Last Stand for Green Macaw

Costa Rica's Green Macaw(Ara ambigua) is nearly extinct. Only 25 to 35 breeding macaw pairs remai in the country. The Rainforest Alliance and the World Conservation Union (IUCN) have joined forces to for a Coaltion with Costa Rica's grassroots organizations.

Almendro trees are vital to the birds for nesting and for food, but, like many trees it is being over-harvested.

decree was issued by Costa Rica's Minister of Environment and Energy requiring landowners to be compensated for the almendro trees they conserve.

MostGreen Macaws are in the northeast section of Costa Rica where

nearly 30% of the forest cover has been reduced between 1986 and 1992. Poachers are another threat to the survival of the Green Macaw.

To help save the green macaw write a short letter to the Environment and Energy Minister - Rene Castro - expressing your desire for strong protective measures to prevent distruction of macaw habitat and to further protect them from the illegal pet trade.

# Midwestern Land Swap to Protect Habitat

Under a proposed land swap, which still is pending approval by Congress, Weyerhaeuser will give the U.S. Forest Service nearly 200,000 acres of mountainous pine and hardwood forest that is not economical for the company to log. In exchange, the government would give

Weyerhaeuser 47,000 acres of prime replanted pine plantation thatt is now part of the Ouachita National Forest located on the Oklahoma/Arkansas border.

The donated tract from Weyerhaeuser includes 10 miles of critical habitat for the leopard darter and 6,000 acres adjacent to the Glover River, the last free-flowing river in Okalhoma. The Federal protection would also expand the habitat of a population of endangered red-cockaded wookpeckers.
